

#### **INTRODUCTION**

Grace Christian Schools of Pasco is an outreach and discipleship ministry of Grace Bible Church. It supports the families of our community in three ways, by providing an academic education that meets the individual needs of students, by developing good character in students through teaching God's Word, and by helping students build a Christian view of the world.

#### **MISSION STATEMENT**

We believe that every child is a precious gift from God. We believe each child is unique and special. They differ in the degree of their spiritual, mental, emotional, physical and social maturity. They develop at their own rate in each of these areas and have individual learning styles with strengths and limitations.

We believe it is our mission to provide a high quality, Christ centered educational program that includes both basic skills and thinking skills. We believe it is our responsibility to provide instruction that will promote success for each child.

Our goal is that upon completion of the prescribed course of study each child will be prepared academically to take his/her place in society, and will have a personal relationship with Jesus Christ that will give direction throughout life. In short, our mission is to evangelize, educate. equip and edify.

#### **GOVERNING BOARD**

Members of Grace Christian Schools of Pasco Committee shall consist of no more than nine members: the senior pastor of Grace Bible Church or his representative, the principal of Grace Christian Schools of Pasco, and seven Grace Bible Church representatives. The principal of Grace Christian Schools of Pasco is a non-voting member of this committee.

#### **AFFILIATION AND MEMBERSHIP**

In 1979 Grace Christian Schools of Pasco was formed as a ministry of Grace Bible Church. Grace Christian Schools of Pasco is a member of the Association of Christian Schools, International (ACSI).

#### NOTICE OF NON-DISCRIMINATORY POLICY

Grace Christian Schools of Pasco admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally afforded or made available to students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

#### **STATEMENT OF FAITH**

This statement of faith describes what we believe and teach about major Biblical teachings and are the positions taken in the classroom by the teachers.

**THE SCRIPTURES** - The Christian Bible, both Old and New Testaments, are the divinely, verbally, inspired, word of God, and without error in the original writings. It is the complete revelation of His will for the salvation of mankind, the true center of Christian union and the supreme and final standard by which all human conduct, creeds, and opinions should be tried. (2 Tim. 3:15-17, 2 Pet. 1:20, Psalms 19:7-9)

**THE GODHEAD -** We believe in the only one true God, who is the Creator, Sustainer, Sovereign Ruler of all things, and eternally existing in three persons (Father, Son, & Holy Spirit), who are equal in nature, attributes, and perfection. (Deut. 6:4, Matt. 28:19, 2 Cor. 13:14)

**PERSON AND WORK OF CHRIST** - The Lord Jesus Christ is true God and true man, the eternal Son of God, conceived of the Holy Spirit, born of the Virgin Mary in order to reveal God and redeem sinful mankind. He accomplished this redemption by offering Himself on the cross bearing our sin, as the sinless substitutionary sacrifice, thereby satisfying God's righteous judgment against sin. After substantiating this redemption by His bodily resurrection from the dead, He ascended to the right hand of God the Father, and intercedes for those who trust Him. (John 1:1, 2, 14, 18; Luke 1:34-35; Rom. 3:24-26, 8:34)

**PERSON AND WORK OF THE HOLY SPIRIT** - The Holy Spirit is the third person of the Trinity, who convicts the world of sin, righteousness, and judgment, and regenerates the unbeliever, and sanctifies and teaches those who believe in Jesus Christ. At the moment of regeneration, the Holy Spirit baptizes seals, indwells, and sovereignly bestows spiritual gifts upon each believer for the edification of the body of Christ. (Eph. 1:13, 4:30; John 16:7-11; 1 Cor. 12) We believe that the gifts of speaking in tongues and the working of sign miracles ceased as the N.T. was completed and its authority established. They were given as signs to the Israelites in fulfillment of O.T. prophecy but were not signs of spiritual superiority or maturity. (I Cor. 12:4-11, 13:1-3, 14:22, 23; and Eph. 4:7-12)

We believe that God may heal miraculously today when it is His perfect will to do so, but healing is not in the atonement. (2 Cor. 12:8-10; Jas. 5:14-16)

**SATAN** - We believe in the distinct personality of Satan, and that he is the unholy god of this age. We hold him to be man's great tempter, the enemy of God and His Christ, the accuser of saints, and author of all powers of darkness, sin, and false religion. He is destined to the judgment of an eternal justice in the lake of fire. (Matt. 4:1-11; 2 Cor. 4:4; Rev. 20:10; John 14:30)

**CREATION** - We believe in the literal 6-day account of creation; that the creation of man lies in the special, immediate, and formative acts of God and not from previously existing forms of life. (Gen. 1:26-27, 2:7-9,16,17, 3:1-19)

**MANKIND** - We believe that human life (mankind) begins at conception (Psalm 139:13 - 16). We believe that mankind was uniquely created in the image of God and is therefore different, special and sacred. (Genesis 1:27, 2:7) God set man above all other life forms. (Genesis 1:28 - 30)

Abortion or the active taking of the life of a human is therefore murder. God only allows for the taking of another human's life as an act of self-defense of self, family or country or as a form of capital punishment in cases of certain crimes. (Genesis 9:6; Exodus 22:2)

The first man, Adam, was created innocent, but through willful disobedience to God, he became spiritually dead bringing sin and physical death into the human race. This spiritual depravity has been transmitted to all mankind, so that man is sinful in nature and by practice. Therefore, regeneration by the Holy Spirit is absolutely essential to the salvation of man. (Gen. 1:26, 3:1-24; Rom. 3:10-18, 5:12; Eph. 2:1-3)

**SEXUALITY AND MARRIAGE -** We believe mankind was created male and female with each fulfilling their sexual role in a heterosexual monogamist marriage. We also believe that all forms of sexual activity outside of a heterosexual marriage are a perversion of God's sexual design. Sex changes, transvestitism, and sexual activity such as homosexuality, lesbianism, sodomy, and pedophilia are sinful perversions, and no child of God can maintain such a sexual lifestyle. (Gen. 2:18-25; Eph. 5:21-33; Rom. 1:24-32; Gal: 5:19-21; 1 Cor. 6:9-11; 1 Jn. 3:4-9). We believe that God desires a man and woman to honor their marriage vows till death parts them (Matthew 19:4). God hates divorce. (Malachi 2:16) God only allows for divorce in cases of fornication/adultery and/or desertion by an unbelieving spouse (Matthew 19:8-9; 1Corinthians 7:15)

**SALVATION -** Salvation is the gift of God's grace, not gained by meritorious works, and freely given to all who trust in the finished work of Jesus Christ at Calvary. Thus, all repentant sinners are forgiven and born into God's family by the regenerating work of the Holy Spirit. Evidence of salvation appears in the holy fruits of repentance, faith, and newness of life. (Eph. 2:8-9; John 1:13; John 3:3-6; Matt 7:16; Titus3:5).

**REPENTANCE AND FAITH -** We believe that repentance and faith are solemn obligations, and also inseparable graces, wrought in our souls by the quickening Spirit of God; thereby being deeply convicted of our guilt, danger, and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession, and supplication for mercy; at the same time heartily receiving the Lord Jesus Christ and openly confessing Him as our only and all-sufficient Savior. (Acts 20:21; Mark 1:15; Acts 2:27-38; Luke 18:13; Romans 10:13; Psalms 51:1-4, 7; Is 55:6,7).

**REGENERATION -** Regeneration is the instantaneous act of the Holy Spirit, whereby the sinner, who is dead in trespasses and sin, is brought to spiritual life and is made partaker of the Divine nature. This act is brought about, not by culture, not by character, nor by the will of man, only by the operation of the Holy Spirit in connection with the Word of God (John 1:12-13; John 3:8).

**JUSTIFICATION** - Justification is the judicial act of God whereby the sinner is declared righteous in view of Christ's shed blood, in which punishment is absolved (having suffered in Christ), and the sinner is restored to Divine favor. (Romans 5:1-9, 4:4-5; Acts 13:39).

**SANCTIFICATION** - Sanctification is the act of God whereby He sets apart the sinner unto Himself for holy living. This is presented in the scriptures in a threefold aspect:

1. POSITIONAL SANCTIFICATION, which is true of every believer (1 Cor: 1:2), the result of the sacrifice of Christ (Heb 10:10), is perfect in its intent and character (Heb. 10:14), and is through the exercise of faith (Acts 26:18).

- PROGRESSIVE SANCTIFICATON begins with salvation and continues until it is brought to completion in the glorified body. It is a result of "growth and grace" (2 Peter 3:18, 2 Cor. 7:1). Every believer is sanctified by the reading of the Word of God, by the Father, Son, and Holy Spirit (Jn. 17:17; Eph. 5:25-26; 2 Cor. 3:18; Phil. 1:6).
- 3. ULTIMATE SANCTIFICATION is attained when the spirit, soul, and body are freed completely from sin and when the believer is brought into the presence of Jesus Christ. (Rom 8:28-30; 1 Jn. 3:2)"...we shall be like Him..."(1 Thess. 5:23).

**SECURITY, ASSURANCE, AND RESPONSIBILITY -** We believe that all the saved, those in whom God has accomplished His transforming work of grace, are kept by His power and are thus secure in Christ forever. It is their privilege to rejoice in the assurance of their salvation. However, this assurance must not be the occasion for sin, for God in holiness cannot tolerate persistent sin in His children, and in infinite love, He corrects them. Faithfulness to Christ is the hallmark which distinguishes them from superficial professors. (John 10:27-30; Rom. 8:31-39; I John 5:13; Heb. 12:6; Matt. 7:20; Jas. 2:20)

**CHURCH** - We believe in the Church, a living, spiritual body, of which Christ is the Head, and of which all regenerated people are members, and that the local visible Church is a company of regenerated baptized believers in Jesus Christ, associated together for work, worship, and fellowship. (1 Cor. 12:1-31; Matt. 16:16-18; Acts 2:42-47).

**ORDINANCES OF BAPTISM AND THE LORD'S SUPPER -** We believe in the observance of the ordinances of Baptism and the Lord's Supper in obedience to the Lord's command; that Baptism is the immersion of a believer in water as his identification with the death, burial, and resurrection of Christ, and is a public recognition of the Lordship of Jesus Christ (Rom. 6:1-7; Matt. 28:19-20).

We believe that the Lord's Supper is a memorial service, for believers, in which the elements of bread and grape juice remind us of the vicarious, bloody sacrifice of Jesus Christ on the cross and is to be observed with solemn, self-examination in anticipation of His second coming. (Matt. 26:26-29; 1 Cor. 11:23-30; Acts 8:36-38; Rom. 6:3-4).

**SECOND COMING OF CHRIST** - We believe in the personal, imminent return of Christ to receive the saints and later to establish His millennial kingdom on this earth, and ultimately to establish His eternal reign in the new heavens and the new earth. (1 Thess. 4:13-18, 5:1-11; Rev. 20:3-7).

**JUDGEMENT** - We believe that the believer's sins are judged in Christ on the cross (2 Cor. 5:21; Gal. 3:13; Jn. 5:24) and that his works will be judged for rewards at the Judgment Seat of Christ at the time of His coming (1 Cor. 3:8-15; 2 Cor. 5:10; 1 Cor. 4:5; 2 Tim 4:8). We believe that the impenitent wicked will be raised at the second resurrection of the dead to stand at the judgment before the Great White Throne of God. This takes place after the thousand-year reign of Christ (Millennium). These will be consigned to the Lake of Fire (Hell), there to suffer torment forever together with the Devil, Antichrist, and False Prophet. We believe that the souls of the impenitent dead are now in a state of conscious suffering in Hades, awaiting the second resurrection (Ps. 9:16; Luke 16:19-31; Ecc. 12:14; Mark 9:43-48; Rom. 2:8-9; Heb 9:27; Rev. 14:9-11; Rev. 20:10-15, Rev.).

**THE ETERNAL STATE** - We believe that at death the souls of those who have trusted Christ for salvation pass immediately into His presence and there remain in conscious bliss until the resurrection of the body at His coming for the Church, when soul and body reunited shall be associated with Him forever in glory. We believe that the souls of unbelievers remain after death in conscious misery until the final judgment and forever thereafter. (Luke 16:26; 2 Cor. 5:8; Phil. 1:23; 2 Thess. 1:7-9; Rev. 20:11-15).

#### **GUIDELINES FOR ADMISSION**

- The entire application packet must be returned, preliminary records received from the previous school (if applicable), and a pre-admission interview completed prior to any student's being considered for admission. In addition, prospective students in grades 7 through 12 must provide three character references, which must also be received prior to the interview. Character references must be mailed, faxed, or hand-delivered by the persons providing the references. References hand-delivered by prospective students and/or their parents must be in sealed envelopes. (Students of these grades must indicate a willingness to cooperate with the school.) Character References forms, along with a stamped envelope, should be provided to each of the following people:
  - (1) the senior or youth pastor of the church that the student attends;
  - (2) the principal or guidance counselor of the school the student has most recently attended; and
  - (3) an adult who is not a household member and not related and has known the student personally for at least one year
- 2. Each prospective student and at least one parent/guardian must have a pre-admission interview with the Admissions Committee prior to a child's acceptance. Parents, as well as 7<sup>th</sup> through 12<sup>th</sup> grade students will be asked to give an account of their salvation experience.
- 3. A registration fee of \$100.00 per child must accompany the registration packet and will hold a place for <u>prospective new students</u> while their applications are being considered. If, for some reason, a prospective new student's application is not approved, the \$100 registration fee will be refunded. However, a refund will not be given to families opting not to enroll after applying. If, for some reason, a student or family is asked not to return, the re-enrollment fee will be refunded. However, a refund will not be given to families opting not to return after re-enrollment fee mill be refunded. However, a refund will not be given to families opting not to return after re-enrolling.
- 4. Each applicant must give evidence of potential academic success in the school's program based on school records, entrance tests, and interviews. Each student must have a grade point average of 2.0 (C) or higher. (Consideration may be given to students with extenuating circumstances.) The principal will assign new enrollees to the appropriate grade level.
- 5. Effective April 1, 2014 All newly enrolled students will be placed on probation for the first 9 weeks of school. The school board will re-evaluate them after this period and make appropriate recommendations. The school board will determine whether the student will be removed or remain on probation or removed from the school.
- 6. Students must be five (5) years old by September 30<sup>th</sup> in order to enter kindergarten.

Grace Christian Schools of Pasco believes that sexual activity outside of a heterosexual marriage is Biblically immoral and in open opposition to what we are trying to teach. Parents who are unmarried but are living together as man and wife and are seeking to enroll their children at Grace Christian School need not apply.

#### **GENERAL POLICIES**

#### SCHOOL HOURS

- 7:30 am Students arrive in classes/campus between 7:30 and 7:55 am
- 8:00 am Classes begin/TARDY at 8:00 am
- 2:45 pm Dismissal of grades K5-5
- 3:00 pm Dismissal of grades 6-12 students and remaining grades K5-5 students.
- 3:15 pm All students remaining on campus must report to the After School Care program <u>unless</u> they are involved in extracurricular activities

#### **ARRIVAL**

Students (K-6) arriving after 7:30 am will go to their classroom.

Secondary students (6-12) arriving after 7:30 am will go to a common location to be determined by administration.

#### **DISMISSAL**

At 2:45 pm students in grades K5-5 are dismissed from the West side parking lot. At 3:00 pm students in grades 6-12 and the remaining K5-5 students are dismissed from the West parking lot. Parents are to remain in their cars in the pick-up line for safety of all children, parents and teachers. Students will be brought to your vehicle by a staff member.

All students <u>not</u> picked up by 3:15 pm will be taken to the extended school day program except those participating in after school curricular activities. Students picked up after 3:30 pm will be charged a fee for this service. Only parent/guardian approved persons will be allowed to pick up students (refer to page 33). Early dismissals must occur prior to 2:30pm. Students will not be allowed to have early dismissal from 2:30pm-3:15pm.

#### ATTENDANCE/ TARDINESS/EARLY DISMISSAL

#### **ATTENDANCE:**

Regular attendance in school is necessary for your student to achieve the best possible education. When a student is absent, he/she suffers academically. As an educational institution, we discourage absences from classes other than those that are absolutely necessary. Excessive absences affect a student's grade and could place his/her promotion in jeopardy. Excessive absences may also affect scholarships.

#### **ABSENCES/TARDIES:**

Absences or tardiness will be excused for personal illness, a death in the family, college visits for 12<sup>th</sup> graders, or pre-planned family activities with written notification to the principal one week before the activity and planned date.

A note from the parent will be required to explain why the student was absent or tardy. The note <u>must always state the reason for the absence or tardy</u>, and the reason must be accepted by the principal. Bring all absence and tardy notes to the school office when the student returns to school.

#### **DISMISSALS:**

When it is absolutely necessary for a parent/guardian to take a child out of class before the normal end of school day, the parent/guardian must send a note or call before the child will be released. The parent must report to the school office and sign the child out. If a student is driving him/herself to an appointment or leaving early for another reason, a note, phone call, or visit from the parent is necessary before the student may leave the campus. The student driver must sign out at the office before leaving campus.

\* Students involved in dual-enrollment at PHSC must provide a parent-signed "permission to leave school" note <u>each</u> year they participate in the program.

Students arriving after 8:00 a.m. <u>or</u> after the beginning of each period (gr. 6-12) are considered tardy. Students arriving late to school must go to the office and secure a late pass and then return immediately to class. Excused tardies must meet the same conditions as excused absences. Students in grades 6-12 with five unexcused tardies will receive one absence. <u>(Oversleeping, sleeping late after ball games and other activities, being caught in traffic and the like, will not be excused.)</u>

Grades 6-12 -If a student is late 25 minutes or more to a class, it will be considered a <u>class absence</u>. Proper written notice with a reason for the absence is necessary.

## Florida State statutes (1011.61) require the following minimal instructional hours for schools:

- Grades Kindergarten- 3: 720 hours per year
- Grades 4-8: 900 hours per year
- > Grades 9-12: 135 hours per year per credit (67.5 hours for ½ credit)

Florida Statute 1003.436 advises that a [secondary] student may not be awarded a credit for graduation if he/she has not been in attendance for instruction for a "minimum of 135 hours". A secondary student who is absent more than 10 days per semester will fail each subject in which he/she has more than 10 absences, even if he/she has a passing grade. All absences, (excused or unexcused), count toward the limit of 10 days per semester. The number of planned absences may be no more than five days for secondary students.

Students with excused absences or tardies will have two days to make up work or tests for each day absent; up to 10 school days (absent three (3) days = up to six (6) days to make up work). Students with <u>unexcused</u> absences will receive a zero for homework or tests that they missed.

If a student has had at least ten (10) absences or tardies within a calendar month it will be reported to the school principal or his designee that the student may be exhibiting a pattern of non-attendance. The school principal or designee will contact the parent/guardian to resolve any possible issues. If the initial parent/guardian meeting does not resolve the problem, then additional interventions may be utilized to resolve the problem.

#### CODE OF CONDUCT (Students)

We believe that parents have the primary responsibility for the discipline of the child. The school will not spend a disproportionate amount of time dealing with discipline problems. Grace Christian Schools of Pasco is dedicated to the training of children in a program of study, activity, and living that is Christ-centered. Discipline is firm, consistent, fair, and tempered with love. Our faculty maintains standards that encourage good behavior in the classroom through kindness, love, and a genuine regard for their students. When disciplinary action becomes necessary, it is carried out with firmness, tempered by good judgment and understanding.

The teacher will initially correct misbehavior. When warranted, the teacher will confer with the assistant principal or principal and/or parents to resolve a behavioral problem. When a student's behavior is continuously in discord with school policies and/or principles, that student may be placed on probation. The parents will be notified of such in writing and may be called in for a conference. If a student's conduct or cooperation with the school is not in keeping with the school's requirements and/or interferes with the educational process, that student's enrollment may be ended by the school.

The following is a list of activities that <u>will **not** be tolerated</u> at Grace Christian Schools of Pasco by any student, as well as the penalties that the School Committee has determined will be assigned for violation of school policies. Penalties will be grade level appropriate. The Code of Conduct is subject to change. Final interpretation of the Code of Conduct will be made by the principal and/or School Committee.

- 1. Cheating, copying, or allowing work to be copied, either on or off campus (elementary students "F" on the assignment or test and a possible suspension); (secondary students "0" on the assignment or test and one day of in school suspension for the first offense; "0" and one detention plus one day of suspension for the second offense; "0" and two days of detention plus one day of out of school suspension for the third offense; "0" and expulsion from school for the fourth offense)
- 2. Chewing gum while on campus, on the bus, or on field trips (infraction or detention)
- 3. Skipping one class (one day suspension); skipping all day (two-day suspension)
- 4. Forging another's signature (one day suspension)
- 5. Fighting (which includes hitting, biting, slapping or punching) while on campus or at school functions (1-10 day suspension)
- Cursing, using vulgarity, telling off-color jokes, or making obscene gestures, including mooning, while on campus or at school functions (one or more days suspension)
  \*If you have any questions about inappropriate words, a list can be provided upon request.
- 7 Deliberate destruction of, damage to, or defacing of school, church, and/or faculty property (10 day suspension or expulsion and the student must pay the cost of any repairs)
- 8. Public display of affection (includes holding hands) while on campus or at school functions (detention and/or suspension)
- 9. Touching other students while on campus or at school functions (considered an invasion of privacy may be subject to disciplinary action)
- 10. Any arrest or immoral conduct, either on or off campus including but not limited to fornication, adultery, homosexuality, or other forms of sexual misconduct- (up to expulsion) (Refer to the Statement of Faith; boyfriends and girlfriends cannot live together.)
- 11. Unauthorized use or possession of tobacco (includes smoking, dipping, chewing and

vaping), either on or off campus - (five days of out-of-school suspension for first offense; expulsion for second offense) Possession or use of fire producing lighters (suspension)

- 12. Use, possession, or distribution of alcohol or illegal drugs, either on or off campus (expulsion)
- 13. Lying or disrespect while on campus or at school functions (1-2-day suspension).
- 14. Use, possession, or distribution of <u>any</u> over-the-counter or prescription medication while on campus or at school functions. (up to expulsion)
- 15. Belligerent or derogatory comments about the school, staff, administration, or other students while on campus or at school functions (detention, and/or suspension)
- 16. Stealing or taking someone's property without permission (includes removing articles from a hallway or locker and eating another person's lunch) (1-2 day suspension)
- 17. Possession of firearms, ammunition, knives, weapons, fireworks, lighters and other incendiary devices while on campus or at school functions (expulsion)
- 18. Inappropriate driving while on campus or at school functions (driving privileges suspended for one week for first offense; driving privileges suspended for one month for a second offense)
- 19. Possession or viewing of pornographic material either on or off campus (subject up to expulsion)
- 20 Playing loud and/or inappropriate music on car radios while on campus or at school functions (driving privileges suspended for one week)
- 21. Possession of any electronic equipment including, but not limited to, cell phones, laptop or tablet computers, gaming devices, portable radios, tape players, smart watches (internet capable) etc. while on campus without administrative pre-approval -(confiscation of item and returned to a parent guardian and an infraction)
- 22. Failure to return Progress Reports within two (2) days and/or Report Cards within one (1) weeks allotted time (1-hour detention will be issued for grades 6-12 students.)
- 23. Failure to serve detention (additional 1-hour detention for first offense; additional 1 hour detention and suspension from school until detention is served for further offenses)
- 24. Inappropriate behavior during detention (dismissal from detention and additional 1-hour detention for first offense; dismissal from detention, additional 1-hour detention, and suspension from school until detention is served for further offenses)
- 25. Repeated dress code violations (subject to detention and/or suspension)
- 26. Body piercing-any visible body piercings are subject to a minimum one-day suspension.
- 27. Tattooing, including visible temporary or permanent tattoos are prohibited. Any visible tattoos are subject to a minimum one day suspension.

#### **INFRACTIONS:** (Grades 6-12)

Any failure to abide by school rules or class rules may result in an infraction. If a student accumulates three infractions in a quarter, he/she will receive a 1-hour detention.

The assistant principal or principal may administer more severe discipline in cases where there is reoccurring, frequent or aggravated violations of the school rules.

#### **DETENTION:**

**Grades 3-5**: A teacher may issue a detention for infraction of school or classroom rules. The administration will review infractions and detentions. A detention slip will be issued at least one day before the scheduled detention so that transportation arrangements can be made. <u>This slip must be signed and returned by the detention date.</u>

**Grades 6-12**: A detention slip will be issued at least one day before the scheduled detention so that transportation arrangements can be made. <u>This slip must be signed and returned by the detention date</u>. Students whose detention slips are not signed and returned will receive additional detentions until their slips are signed and returned. If a student cannot serve a detention on the date assigned, a note from the parent/guardian with explanation must be submitted. Detentions are work details around the school grounds. Detentions will normally be assigned for after school hours Tuesday – Friday; however, occasionally detentions will be assigned for a Saturday. Parents will receive phone notification if a Saturday detention is assigned.

Infractions per Quarter:	3  infractions = 1 -hour detention
	3 more (6 total) = 2-hour detention $30.00$ charge
	3  more  (*9  total) = 4 -hour detention plus a  60.00  charge

(\*A Discipline Meeting will be required)

Additional infractions may result in further discipline such as suspension, probation or removal from the school.

#### **DISCIPLINE MEETING**: (Grades 6-12)

When a student has received 12 or more infractions a parent conference (to include the student, parent, assistant principal or principal) is required before the student may return to class.

#### **SUSPENSIONS**

**ISS** (In School Suspension) – This is a working suspension. Students are to report to the school office in the morning in appropriate work clothes (a solid colored T-shirt and jeans and sneakers). Students are not permitted to attend classes; however, they are expected to get their missed work from their teachers at the end of the day. They must complete all missed work. They will receive credit for the work.

<u>OSS (Out of School Suspension)</u> – Students are not permitted to be at school or on school property for the duration of an Out of School Suspension. They are required to make up missed work (homework, quizzes and tests) but they will receive zeroes. This is also recorded as an unexcused absence.

#### **PROBATION**

Probation is meant to be a time of observation and reporting of a student's progress and performance. Students will be placed on probation for one of the following reasons:

1. All new incoming students will be placed on probation to help them acclimate to Grace

Christian Schools of Pasco. This is not a disciplinary action for new students. The normal probation period for new students is nine weeks. However, some students may stay on probation for longer periods of observation and reporting.

- 2. Students will be put on probation if they are academically failing one or more subjects and it is recommended by a teacher, the principal or the school committee. Students will remain on probation until they are passing all classes and/or they have a 2.0 grade point average.
- 3. Students will be put on probation if they have unsatisfactory attitudes and/or behaviors and it is recommended by a teacher, the principal or the school committee. Students will remain on probation until the student has satisfactory improvement in attitude and/or behavior. If satisfactory improvement is not achieved after a period of time, determined by the school committee, the student will be suspended or expelled.

Students on probation will have monthly observation reports completed by their teacher(s) and reviewed by the principal and school committee. Teachers will meet with the parents/guardians of probationary students every two or three weeks to review the students' progress. Parents/guardians will receive weekly progress reports and all assignments will be made available to the students and parents/guardians at the beginning of each week.

#### DISMISSAL/EXPULSION FROM SCHOOL

The school reserves the right to deny admission to or dismiss any student or family for any reason that the principal and/or School Committee deems necessary. This includes, but is not limited to, failure to cooperate with the educational process, an inability to respond to our curriculum, chronic unexcused absences or tardiness, persistent dress code violations, and rebellion toward discipline on the part of the student, as well as attitude incompatibility, chronic complaining, sowing discord, unchristian conduct, and a lack of compliance or support on the part of either the student or the parents/guardians.

#### **RULES OF GOOD CONDUCT**

- 1. Students are to be honest, courteous, and kind at all times.
- 2. Respect for teachers and other adults is expected and required. (Teachers will also address the students with respect.)
- 3. During regular school hours, students must be signed out by a parent or guardian before leaving school grounds, regardless of their reason for leaving early.
- 4. If the student drives themselves to school they must have their parent's written permission and sign out before leaving school grounds during regular school hours, regardless of their reason for leaving early.
- 5. There is to be no running, horseplay, or excessive noise in the hallways.
- 6. Students cannot leave or have other students or people, except their parents, leave school to get food for them.
- 7. Candy, food, and beverages are to be eaten in designated areas only.
- 8. Gum chewing is not allowed on campus.
- 9. Students are to be in their seats and ready to begin class with all necessary materials when class is scheduled to begin.
- 10. Students are not to talk in class unless they raise their hands and are recognized.
- 11. Students are to stay in their seats during class unless given permission to get up by the teacher.
- 12. Students must have permission from the principal to sell anything on school grounds.

#### CODE OF CONDUCT (Parents/Guardians)

#### **CONFLICT RESOLUTION**

We welcome suggestions or questions by parent. It is important to keep the lines of communication open between teachers, parents, administration and the school board. Grace Christian School follows the guidelines set forth in Matthew 18:15-17 as the standard for conflict resolution. If a parent has a problem with a teacher, an appointment should first be set up with the teacher to discuss the problem. Usually any issues can be resolved at this meeting. If unresolved on this level it is then appropriate to request a meeting with the teacher and the principal.

#### PARENT RESPONSIBILITIES

- 1. Please refrain from smoking or chewing tobacco products, vaping, drinking alcoholic beverages or participating in any questionable activity while on school grounds or while representing Grace Christian Schools of Pasco.
- 2. Grace Christian Schools of Pasco believes that God has commanded that sexual activity should be between one man and one woman who are <u>married to each other</u>. Parents/Guardians are to refrain from cohabitation without the benefit of marriage as it could result in the dismissal of your student(s) from Grace Christian Schools of Pasco.
- 3. Please keep in mind that our conversation is to be a "sweet smelling savor" to our Lord. Please refrain from using profanity and vulgar or inappropriate language on campus and at school sponsored activities. Loud conversations inside or outside the buildings are inappropriate.
- 4. Please refrain from gossiping. If you have any issues that need to be discussed, please make an appointment to see the principal.
- 5. Please refrain from holding "parent conversations" in the school hallways.
- 6. Whenever you are on campus your dress should be modest and appropriate for the activity. Clothing should not be cut low at the neckline, too tight, too short, or have inappropriate or offensive language on it.
- 7. If you are in your vehicle on campus, be sure your music is appropriate and is on low volume.
- 8. When chaperoning a field trip, please abide by the rules and regulations established by the school and the classroom teacher.
- 9. Be sure to check your student's satchel or back-pack daily for Progress Reports, field trip forms, homework assignments, teacher notes etc. Be sure to sign all appropriate papers and return to the teacher promptly.

#### PARENT/TEACHER CONFERENCES

Open communication between parents and teachers is important. We appreciate the support you give to the teacher by being involved in your child's education process. Written notes are the most helpful means of communication, however, if you need a meeting, please schedule an after-school appointment. Conferences at drop-off or during the school hours are not appropriate. For a brief up-date on your child's progress, Parent Meetings are scheduled two times a year (see the Activity Calendar for dates).

#### **GENERAL DRESS CODE**

#### **GIRL'S DRESS CODE**

We believe the way students dress strongly influences their behavior, self-image, and the effort they exert in school. It is our desire to encourage students to develop an attitude about their appearance, which will show a high degree of self-respect and self-worth. The school dress code is intended to guide students to dress in a clean, neat, and modest fashion, which reflects self-respect and femininity in girls. All clothes should reflect a girl's desire to be modest; emphasizing a sense of what is fit and proper at all times. A girl's dress should display modesty in correct fit, including length and necklines.

All students are expected to dress neatly and modestly. Clothing appropriate for specific activities may be worn with permission, but must still meet the general spirit of the dress code. This standard will apply to field trips, athletic events, banquets, and all other school functions.

The Dress Code is subject to change. School personnel will make final interpretation. Questions as to the acceptance of clothing not specifically addressed in the dress code should be discussed with the Principal. Generally, a conservative position will be held. All dress and hair code rules and regulations are in effect until the students leave the school campus.

**Pants** ... Pants must be "uniform-type" with traditional pockets, front and back with no rivets on the pockets, and may be either navy, khaki, olive green, forest green, or black. Pants must fit properly. Athletic pants, bell-bottoms, Hip-huggers, Low-riders, Capri pants, cargo pants, carpenter pants, corduroys, overalls, sweat pants, jogger-style (elastic bottom), stretchy material and any other type not generally considered "uniform" are PROHIBITED. Pants may NOT be too tight or too baggy. Pants may <u>not</u> be of stretch type material.

**Skirts** ... Skirts must be "uniform-type" and may be either navy, khaki, olive green, forest green, or black. Skirts must fit properly and must reach the top of the knee or longer. Corduroy skirts, denim skirts, "denim-look" skirts, spandex-type skirts, and any other type not generally considered "uniform" are PROHIBITED. Skirts may NOT be too tight or too baggy. Skirts whose lengths or slits are higher than the top of the knee is PROHIBITED. (Wearing leggings does not allow for skirts to be worn shorter than the dress code standard, and the leggings must be a solid color.)

**Jumpers** ... Jumpers must be "uniform-type" and may be navy, khaki, olive green, forest green or black. Jumpers must have the "Grace Christian School" monogram. Jumpers may only be worn with polo-style shirts and/or turtlenecks underneath. Jumpers must reach the top of the knee or longer. Corduroy jumpers, denim jumpers, "denim-look" jumpers, overall jumpers, spandex-type jumpers, and any other type not generally considered "uniform" are PROHIBITED. <u>Dresses and one-piece jumpers are not permitted at this time.</u>

**Shorts & Skorts** ... K-5 through 6th grade students may wear navy, khaki, olive green, forest green, or black modest length "uniform type" shorts with a minimum length of 2 inches above the knee or longer. Shorts and skorts must fit properly. Athletic shorts, cargo shorts, carpenter shorts, corduroy shorts and skorts, denim shorts and skorts, "denim-look" shorts and skorts, overall shorts and skorts, sweat shorts, and any other type not generally considered "uniform" are PROHIBITED. Shorts may NOT be too tight or too baggy. Grades 7-12 are PROHIBITED from wearing shorts or skorts.

**Shirts** ... All shirts must be "polo-style" with the "Grace Christian School" monogram and may be ordered through the school. Shirts must fit properly. Backs and stomach may not show when hands are raised. Shirts other than "Grace Christian School" polo-style shirts are PROHIBITED. Shirts may NOT be too tight or too baggy.

**Turtlenecks** ... Turtlenecks may be worn under "Grace Christian School" polo-style shirts or "Grace Christian School" jumpers. Turtlenecks may NOT be worn without either "Grace Christian School" polo shirts or jumpers over them.

**Fleece/Sweatshirts** ... The new gray fleece or the navy zippered Grace Christian School approved sweatshirts have to have the Grace Christian School embroidered. <u>The gray hooded approved sweatshirt with screen print design can only be ordered at the beginning of the school year.</u> Uniform fleeces/sweatshirts can be worn in the classroom

**Sweaters** ... may be worn to school during cold weather, but are not permitted in the classroom.

**Jackets ...** Jackets can be worn to school during cold weather and at recess but not in class. Jackets cannot have inappropriate language or graphics on them.

**Belts** ... Belts are optional. Belts may be worn with pants, skirts, shorts and skorts that have belt loops. Belts if worn must be solid in color. Belts may NOT be oversized or hang down in the front.

**Shoes** ... Tennis shoes, as well as most other shoes, are permitted. 7th through 12 grade girls may wear high heels up to 2" high. Backless shoes and flip-flops are PHOHIBITED. Girls under 7th grade may not wear high heels. Boots must be mid-calf or lower, no full length to the knee boots. Crocs or croc like shoes are not permitted, sandals must have a strap on the heel.

**Socks or hosiery** ... Socks or hosiery must be worn at all times, unless sandals or open-toed shoes are worn. Thigh high or knee socks may be worn. Fishnet stockings and knee-high nylons are not permitted.

Undergarments ... Undergarments cannot be visible.

**Hats and caps** ... Hats and caps may only be worn OUTSIDE and may only be worn before and after school. Hats and caps worn inside of the building or during school hours will be confiscated and returned to parents.

#### Jewelry and fashion accessories ...

Jewelry and fashion accessories, (i.e. Earrings, necklaces, watches, and bracelets, etc.) may be worn in moderation. This is subject to the interpretation of school administration. Gloves are not permitted in the classroom. Chains and ropes may not be worn around the neck or on wallets, keys, etc. Ladies are only permitted to have two (2) pair of pierced earrings in their ears.

**Body piercing** ... Body piercing of any type (i.e. Tongue rings, belly-button rings, eyebrow rings, gauges and nose-rings) is PROHIBITED.

**Make-Up** ... 7th-12th grade girls may wear makeup in moderation. This is subject to the interpretation of school administration. Girls under 7th grade may NOT wear makeup.

**Hair** ... Hair is to be kept clean, appropriately cut, and neatly styled. This is subject to the interpretation of school administration. Hair must be of <u>natural</u> color.

**Tattoos** ... Tattoos (temporary and permanent) are **PROHIBITED**. Pre-existing tattoos before enrollment must be covered at all times.

#### **BOY'S DRESS CODE**

We believe the way students dress strongly influences their behavior, self-image, and the effort they exert in school. It is our desire to encourage students to develop an attitude about their appearance, which will show a high degree of self-respect and self-worth. The school dress code is intended to guide students to dress in a clean, neat, and modest fashion, which reflects selfrespect and manliness in boys. All clothes should reflect a boy's desire to be modest; emphasizing a sense of what is fit and proper at all times.

All students are expected to dress neatly and modestly. Clothing appropriate for specific activities may be worn with permission, but must still meet the general spirit of the dress code. This standard will apply to field trips, athletic events, banquets, and all other school functions.

The Dress Code is subject to change. School personnel will make final interpretation. Questions as to the acceptance of clothing not specifically addressed in the dress code should be discussed with the Principal. Generally, a conservative position will be held. All dress and hair code rules and regulations are in effect until the students leave the school campus.

**Pants** ... Pants must be "uniform-type" with traditional pockets, front and back with no rivets on the pockets and may be either navy, khaki, olive green, forest green, or black. Pants must fit properly. Athletic pants, bell-bottoms, low-riders, Hip-huggers, Capri pants, cargo pants, carpenter pants, corduroys, overalls, sweat pants, jogger style (elastic bottom) and any other type not generally considered "uniform" are PROHIBITED. Pants may NOT be too tight or too baggy. Pants may not be of stretch type material.

**Shorts** ... K5 through 6th grade students may wear navy, khaki, olive green, forest green or black shorts with a minimum length of 2 inches above the knee. Shorts must fit properly. Athletic shorts, cargo shorts, carpenter shorts, corduroy shorts, denim shorts, "denim-look" shorts, overall shorts, sweat shorts, and any other type not generally considered "uniform" are PROHIBITED. Shorts may NOT be too tight or too baggy. Shorts must have traditional front and back pockets. Grades 7-12 may not wear shorts.

**Shirts** ... All shirts must be "polo-style" with the "Grace Christian School" monogram and may be ordered through the school. Shirts must fit properly. Shirts other than "Grace Christian School" polo-style shirts are PROHIBITED. Shirts may NOT be too tight or too baggy.

**Sweaters** ... may be worn to school during cold weather, but are <u>not</u> permitted in the classroom.

**Jackets** ... Jackets can be worn to school during cold weather and at recess but not in class. Jackets cannot have inappropriate language or graphics on them.

**Fleece/Sweatshirts** ... The new gray fleece or the navy zippered Grace Christian School approved sweatshirts have to have the Grace Christian School embroidered. <u>The gray hooded approved sweatshirt with screen print design can only be ordered at the beginning of the school year.</u> Uniform fleeces/sweatshirts can be worn in the classroom

**Belts** ... Belts are optional. Belts may be worn with all pants and shorts that have belt loops. Belts must be solid in color. Belts may NOT be oversized or hang down in the front.

**Shoes** ... Tennis shoes, as well as most other shoes, are permitted. Sandals and flip-flops, crocs and croc like shoes and bedroom slippers are PHOHIBITED.

Socks ... Socks must be worn at all times.

Undergarments ... Undergarments cannot be visible.

**Hats and caps** ... Hats and caps may only be worn OUTSIDE and may only be worn before and after school. Hats and caps worn inside of the building or during school hours will be confiscated and returned to parents.

**Jewelry and fashion accessories** ... Jewelry and fashion accessories (i.e. necklaces, watches, and bracelets, etc.) may be worn in moderation. This is subject to the interpretation of school personnel. Gloves may not be worn in the classroom.

**Earrings & Body piercing** ... Body piercing of any type (i.e. Earrings, tongue rings, bellybutton rings, eyebrow rings, gauges and nose-rings) are PROHIBITED.

**Tattoos** ... Tattoos (temporary and permanent) are PROHIBITED. Pre-existing tattoos before enrollment must be covered at all times.

**Hair** ... Hair is to be kept clean, appropriately cut and neatly styled. This is subject to the interpretation of school administration. Hair may NOT touch the collar, the ears, or the eyebrows when in a normal wearing position. Hair must be a <u>natural color</u>.

**Facial Hair** ... Facial hair, if worn, must be intentionally grown, neat, and closely trimmed. Male students without beards are to be cleanshaven. Sideburns may only be grown to the bottom of the ear. Sideburns may NOT grow past the bottom of the ear.

#### ALTERNATIVE DRESS CODE ... With administrative approval

#### • Friday Dress Code:

Friday T-Shirt with traditional uniform bottoms or Jeans. Jeans cannot be torn or have holes. See uniform pant standards for descriptions of type and fit.

#### • SPIRIT DAYS

On Spirit Days students and teachers can participate. Students must dress modestly and safely. Students are encouraged to participate in Spirit Days, but they are not required to participate. If a student does not participate they must wear the regular school uniform. Students must still follow the dress code with a few exceptions. Shirts do not have to be tucked in. Clothing does not have to match. Students can wear classic cut jeans.

Flip flops, crocs, bathroom slippers, cleats, ice skates, roller skates are not allowed. **No** holes in the garments and no skinny jeans (pants). **No** tank tops, temporary tattoos, hair dyes, or face painting. Grades 7-12 <u>cannot</u> wear shorts.

#### **Field Trips**

Regular Grace Christian School dress code should be worn on all field trips unless alternate dress is approved by the principal.

#### Homecoming Week

During homecoming week, the students may dress according to the theme as instructed remaining within the Grace Christian School guidelines.

#### Homecoming Banquet: Formal Attire

Gentlemen must wear a coat and tie, dress shirt, dress pants and dress shoes.

**Ladies** must dress modestly in gowns or party dresses that touch the top of the knee or longer. The neckline must be modest and have no cleavage showing, and no deep V. Ladies may not have their backs exposed. Dresses may not have sheer see-through material in inappropriate places. Dresses with skinny straps or strapless must be covered with a jacket or a shawl that is not see-through, and it must remain on at all times. Final decisions on the dress code are at the discretion of the Administration.

#### ATHLETIC DRESS CODE

**P.E. Uniform**: Students in grades 6-8 (and when necessary grades 9-12 for credit) have P.E. every day. The P.E. uniform navy blue shorts must be purchased through the school. The solid-colored gray tee shirt must be purchased through the school. The shorts must have a minimum of a 7-inch inseam length and must be loose fitting. P.E. uniforms must not be see-through.

Students who participate in athletic programs (extracurricular activities) will remain in regular school dress code unless authorized to change into athletic wear by the principal, athletic director or the coach.

**<u>Practice Attire</u>**: Students are required to wear solid colored t-shirt with athletic shorts that are loose-fitting and they must be at least finger-tip length or longer and approved by the coach. Athletic shoes/sneakers with socks must be worn for practice.

#### Game Attire:

Team participants may be dismissed to change into standard uniform as specified by the athletic director, coach or principal. Uniforms will include the proper game color shirt, including under shirt if required, uniform shorts, socks and sneakers/footwear.

#### EXTRACURRICULAR ELIGIBILITY

#### ATHLETIC REQUIREMENTS

Joining an athletic team is a commitment. Games and practices are not optional. Participation in extracurricular activities is a privilege and not a right.

Students participating in athletics are required to have on file the following:

- A current year Florida Athletic Physical Form (in addition to school Health Physical)
- A current year Athletic Participation Form
- > A copy of the Health Insurance that covers the student

Student Requirements:

- Students will be held accountable for maintaining a standard of proper Christian conduct on and off the court/course/field. Any student may be removed from the team for misconduct at the discretion of the administration.
- Students earning an "F" in any class, or less than a 2.0 GPA, on a quarterly report card will become ineligible to play a sport. Ineligible students may practice and attend meetings. Students need to pass all courses in the previous quarter and have at least a 2.0 GPA to play in games. Eligibility for the first quarter of the school year will be determined using the fourth quarter of the previous year. Students who earn eligibility will remain eligible for the entire quarter.
- Students failing classes during respective sports seasons will be required to attend homework help sessions after school prior to arriving at practice sessions. Grades will be checked weekly or sooner at the option of the Athletic director.
- Students who do not have their uniform/equipment on game day will not be permitted to travel with the team or sit the bench.
- Students who earn an ISS or OSS will not be permitted to participate in practice or games for the week they serve the ISS or OSS.
- <u>Students must attend at least a half day (3<sup>1</sup>/<sub>2</sub> hours) of school on game day or they will not travel</u> with the team, suit up or sit the bench for that game.
- Students are encouraged to fully attend and fully participate in practice sessions. Attendance, academics, attitude, ability and effort are key considerations of coaches for court time during games.
- Students must bring money for their own meal for away games. Coaches will seek cost efficient dining options along the travel route.
- Students will contact their parents/guardians approximately 20-30 minutes prior to arriving back at GCS from away games. Please be prompt with student pick up. Repeated occurrences of coaches having to remain with students after games (home or away), or practice sessions for extended periods of time risk having their student(s) not participate in future games. If there is a transportation concern, please advise the coaches who will try to assist with reasonable accommodations, if possible.
- Students leaving with a designated parent/guardian from <u>ALL</u> games and practices <u>MUST</u> have their parent/s address their coach directly that they are leaving with their designated parent/guardian and the coach <u>MUST</u> be certain the student is leaving with a designated parent/guardian. SAFETY IS PARAMOUNT!

#### Honors Club

#### Honor's Club Requirements (rev. 6.21.2011)

- 1. Returning students must be on Honor Roll (all A's and B's) or Principal's List (all A's) for the 4<sup>th</sup> quarter of the previous year and all 3 quarters of the current school year.
- 2. New Students must be on the Honor Roll or Principal's List for all 3 quarters of the current school year.
- 3. Student may not have any suspensions or accumulate more than 2 hours of

detention of the current school year.

- 4. Students must pay a \$50.00 non-refundable deposit after second quarter for the Honors trip.
- 5. Students must help with all fundraisers or be responsible for their part of the expenses for the trip.
- 6. All money raised for the Honors Trip is the property of the Honor's Club. If any student cannot go on the trip for any reason, all money that they have raised or contributed will go toward the next trip the Honor's Club takes.
- 7 If the Honor's Club does not raise enough funds for the trip, all Honor's Club members going on the trip will be responsible for the difference.

#### **Student Council**

Students serving on the Student Council must commit to full participation by attending all meetings and functions and participating in all fund raisers. Students that have several discipline issues, suspensions and failing grades will not be allowed to serve on Student Council.

Each school year students can join clubs to broaden their educational knowledge and experience at Grace Christian Schools of Pasco. Students are encouraged to participate in various clubs, such as STEM, chess, literature, cooking, music, math, etc. when they are available.

#### FINANCIAL RESPONSIBILITY

All tuition payments are due on the first business or school day of each month beginning in August and ending in May. Accounts are considered delinquent by the 10<sup>th</sup> of each month and a \$20.00 late fee will be assessed for that month. If payment remains unpaid by the 20<sup>th</sup> of the month, a \$1.00 per day late fee will be charged from the 21<sup>st</sup> day of the month through the last day of the month. If a payment becomes 30 days past due, the student will be suspended until the account is brought up to date. A \$25.00 fee will be charged for checks returned due to "insufficient funds." If a check is returned for any reason for payments of any school program, the school will <u>NOT</u> accept checks from this account for the remainder of the school year. In cases of student withdrawal from the school, school records will <u>not</u> be released until full payment of tuition, fees, and/or any other unpaid balances are made.

#### WITHDRAWING AND/OR END OF YEAR FINANCIAL RESPONSIBILITIES

Parent/guardians are responsible to keep all fees paid and current. Any delinquency in fees owed will result in report cards and/or other records from being released. If fees become delinquent a notice will be given to the person responsible or the bill. Once the fees are paid in full then the records will be released. If a student is withdrawn at the end of the school year or prior to the end of the school year, then the parent/guardian will be responsible to contact the school office and complete a Withdrawn Form. This person will then be required to make contact with the bookkeeper to ascertain if any fees are owed. Scholarships do not pay all fees if a student

withdraws before the end of the school year. Once all fees and unpaid balances are paid in full, then records can be released. We will strive to have all records up to date and released within one week of full payment of all monies owed. Fees include lunch money, before and after care; tuition, registration, graduation fees, material fees and any other unpaid balances that may have occurred. Any overpayments will be processed as quickly as possible and returned to the appropriate person(s).

#### **TUITION & FEES**

<u>MATERIALS FEES</u>: A non-refundable **\$570.00** Books & Materials Fee OR a **\$720.00** for Books, materials and classroom supplies fee (<u>per student</u>) must be paid <u>prior to August 1<sup>st</sup></u>.

**<u>REGISTRATION FEES</u>:** A registration fee of \$100.00 per child must accompany the registration packet and will hold a place for <u>prospective new students</u> while their applications are being considered. If, for some reason, a prospective new student's application is not approved, the \$100 registration fee will be refunded. However, a <u>refund will not be given</u> to families *opting not to enroll* after applying.

#### **<u>RE-ENROLLMENT FEES</u>**:

The appropriate re-enrollment fee must accompany the re-enrollment packet in order for us to hold a place for <u>returning students</u>. The re-enrollment fees for returning families are as follows: **March & April -** \$ 50.00 per child **May & June -** \$ 75.00 per child **July & August -** \$100.00 per child

#### **RE-ENROLLMENT DISCOUNT:**

For second and subsequent years of enrollment, families whose fees are current by December 1<sup>st</sup> will receive half off of December's tuition. Also if fees are current by May 1<sup>st</sup> you will receive half off of May's tuition payment.

#### FAMILY TUITION REDUCTION:

Volunteer 10 hours for the school and receive a \$100 tuition discount at the end of the year. Families receiving a scholarship *will not* qualify for the \$100.00 discount.

**<u>REFERRAL DISCOUNT</u>**: Any parent who recommends the school to a new parent, who then enrolls their child(ren) in our school for the entire year, qualifies for the referral discount. The recommending parent will receive a referral discount of \$250. This discount will be credited to the last month's tuition. Referrals must be made prior to registration. Please be sure to write the name of the referred family on the Financial Agreement and notify the bookkeeper which family you referred when requesting the referral discount.

#### **MULTIPLE CHILDREN DISCOUNT:**

 $2^{nd}$  and more children = 10% discount

#### **ATHLETIC FEES:**

A non-refundable annual sports fee of \$40.00 per sport is required to participate in any sports offered. Students in grades 6-12 who participate in the Athletic Program will also incur extra fees for uniforms and equipment required. We make every effort to keep these costs at an affordable

#### **GRACE CHRISTIAN SCHOOL SCHOLARSHIPS:**

\**Pastor's Discount*: Full-time pastors are eligible for a 25% tuition discount.

\**Full-time Christian Worker Discount*: Full-time Christian workers are eligible for a 15% tuition discount. Registration fees are <u>not</u> waived.

\*Grace Bible Church Active members are eligible for a 10% discount. Registration fees are <u>not</u> waived.

(\* Upon request and approval of the school board.)

#### Step Up For Students Scholarships / AAA Scholarship

Families receiving *full-tuition scholarships* are <u>not</u> eligible for additional scholarships. *Combination scholarships* may <u>not</u> exceed 45% of the student's *tuition cost* and cannot be used to pay *any other fees.* 

#### \* Families requesting multiple discounts must see the principal.

\* All families (including Step Up for Students and AAA scholarships) will be required to pay any outstanding balance at the time of withdrawal.

If, for some reason, a student or family is asked not to return, the re-enrollment fee will be refunded. However, a **refund will not be given** to families *opting <u>not</u> to return* after re-enrolling. No student has a *right* to re-enroll and applications for re-enrollment will be approved at the sole discretion of the school.

We are happy to provide this service for your family, but please keep in mind that the Extended Care workers have family responsibilities and appreciate you picking up your children on time.

- Students with cell phone are to leave their phone with the daycare supervisor when entering the room.
- Daycare is a separate service provided for your children. Please pay <u>separately from tuition</u> or lunch.
- Parents of children participating in the Extended Daycare Program on a *drop-in basis* <u>will be</u> <u>billed</u> for the care provided.
- Parents of children participating in the Extended Daycare Program on a *regular basis* may either **pre-pay** the entire amount due for the year **or make monthly payments** on that amount. Payments are to be made by the **first day of each month**.
- ALL students who are *not picked up by 3:15 p.m.* will automatically be *sent to daycare*, and

their parents will be billed for the care provided. Older students may not assume responsibility for their younger siblings.

- ALL students who participate in after school extracurricular activities who, for various reasons are <u>not</u> participating in those activities, are <u>required</u> to go to *Aftercare*. Also, if those students are <u>not picked up</u> immediately upon dismissal from practice they will automatically be *sent to Aftercare*, and their parents <u>will be billed</u> for the care provided.
- A fee of <u>\$1.00 per minute</u> will be charged to parents whose children are *not picked up by* 6:00 p.m.

#### GRADING

Students are graded in the following areas: class work, homework, class participation, skill, comprehension, projects, quizzes and tests. All these factors make up quarter grades. It is important that each student comply, complete and turn in all assignments in order to achieve their best results.

Report Cards are issued approximately every 9 weeks. Progress reports are issued intermittently about every 5 weeks to keep parents informed of their student's progress. For exact dates see the yearly Activity Calendar.

#### **COMMUNITY SERVICE HOURS**

All students in High School (grades 9-12) are required to complete 20 hours of community service each year of High School. Students may complete more than 20 hours each year. Students who have <u>completed</u> 8<sup>th</sup> grade may do community service in the summer prior to the beginning of their Freshman year (9<sup>th</sup> grade). All 20 hours of community service may be completed in the summer prior to starting each High School year.

A minimum of 10 hours will be due by the Wednesday before the end of the first semester. The remaining ten hours will be due by the Wednesday before the end of the second semester. Failure to meet this requirement for the first or second semester will mean that 1 point will be taken from the second quarter grade for the first semester for Bible class or 1 point taken from the fourth quarter grade for the second semester for Bible class for each hour that has not been completed.

Grace Christian School will have two types of community service. One that deals with social issues and qualifies for the Bright Future scholarship and the other is volunteer service that does not meet the Bright Futures scholarship guidelines.

The first type of community Service is defined as identifying a social issue in the community. This requires students to look beyond themselves and reach out to an issue faced by our society (e.g. poverty, abuse, elderly citizen rights). This qualifies for the Bright Future Scholarship. The second type is volunteer service which is defined as helping others when or where it is needed, but does not necessarily address a social issue. Volunteer service may qualify for

scholarships other than the Bright Future Scholarship.

To be eligible to receive one of the Florida Bright Futures Scholarship awards, all students must complete a program of community service work that includes a minimum number of hours:

Florida Academic Scholarship – 100 hours Florida Medallion Scholarship – 75 hours

Prior to starting a community service project, the student must complete a Community Service form and have the project approved by the principal or his designee. Once the project is approved the student will provide to the supervisor of the community service a log to be completed and signed by the supervisor. When the community service project is completed the log will be turned in to the principal or his designee to be reviewed and filed in the student's cumulative folder. Community service hours will not be accepted under the following provisions:

- 1. Students cannot perform community service during the student's regular class hours
- 2. Prior to the summer before entering Grade 9 (Service hours may begin after the last day of 8th grade has commenced)
- 3. Community Service performed after graduating
- 4. As part of a court mandated community service
- 5. An activity for which a student benefited financially or materially for the volunteer service worked
- 6. Family related activities or service to family members (ex: babysitting, completing assigned chores, working in the family store, etc.)
- 7. Service for the sole benefit of a religious house of worship and/or its congregation (altar server, lay reader, Vacation Bible School, working in a church nursery or church choir, errands for the pastor, clerical work)
- 8. Donations, such as Locks of Love or giving blood
- 9. Service work that earns the student academic credit
- 10. Activities, events, or organizations that require fees to be paid to participate
- 11. An activity where there is no responsible adult or supervisor on site to evaluate and confirm student performance. Please note that parents/guardians cannot sign off on community service hours.

#### **GRADE REPORTS**

<u>Progress Reports</u> are issued every 5 weeks to provide up-to-date communication on academic progress of students. <u>They are to be signed by a parent/guardian and returned to school within 72 hours</u>. Grade are also accessible on the MySchoolWorx program 24 hours a day.

<u>Report Cards</u> are issued every 9 weeks. Grades on the quarterly report card can determine student eligibility for various programs including athletics. Students are encouraged to keep their grades in good standing while participating in extra-curricular activities. <u>Report Cards are to be signed</u> and returned by a parent/guardian and returned to the school within one week.

#### **GRADUATION REQUIREMENTS**

The following classifications are set to be considered for High School Grades: Students must have the following cumulative credits by the end of the designated year:

#### Graduating seniors are required to have a minimum passing cumulative GPA of 2.0.

#### EARNING EXTERNAL CREDIT - DUAL ENROLLMENT

Dual enrollment with Pasco-Hernando State College is encouraged for those students entering grades 11-12 who wish to go to college after graduation from Grace Christian Schools of Pasco. Dual enrollment students receive college credit and high school credit for college classes while attending Grace Christian School.

The following criteria apply:

- Students must be enrolled at Grace Christian School. Students must be re-enrolled by May 1<sup>st</sup> to take summer dual enrollment classes.
- Students must have a cumulative non-weighted grade point average of at least a 3.0
- Be recommended by the principal
- ▶ Have a passing score on the CPT, P.E.R.T, SAT or ACT

#### HEALTH

#### **COMMUNICABLE DISEASES**

Grace Christian desires to maintain a healthful school environment by instituting controls designed to prevent the spread of communicable diseases. The term "communicable disease" shall mean an illness that arises because of a specific infectious agent that may be transmitted either directly or indirectly by a susceptible host, infected person or animal to other persons.

A teacher or administration official who suspects that a student or employee has a communicable disease shall immediately notify the principal. The reportable diseases include the following: Acquired Immune Deficiency Syndrome (AIDS), Aids Related Complex (ARC), Amebiasis, an animal bite by a potentially rabid animal, Anthrax, Botulism, Brucellosis, Campylobacteriosis, Chancroid, Dengue, Diphtheria, Encephalitis, Giardiasis (acute), Gonorrhea, Granuloma Inguinale, Hansen's Disease (Leprosy), Hemorrhagic Fevers, Hepatitis, Histoplasmosis, Human Immunodeficiency Virus (HIV), Legionnaire's Disease, Leptospirosis, Lymphogranuloma Venereum, Malaria, Measles (rubeola), Meningitis, Meningococcal Disease, Mumps, Paralytic Shellfish Poisoning, Pertussis, Plague, Poliomyelitis, Psittacosis, Rabies, Relapsing Fever, Rocky Mountain Spotted Fever, R. Rickettsia, Rubella, including congenital, Salmonellosis, Schistosomiasis, Shigellosis, Smallpox, Syphilis, Tetanus, Toxoplasmosis Acute, Trichinosis, Tuberculosis, Tularemia, Typhoid Fever, Typhus, Vibrio Cholera, Vibrio Infections, Fever, COVID or other recognized communicable diseases, infections, or parasites.

Any student who is suspected of having a contagious infestation (e.g. Head lice, nits) shall be referred to the principal and to the parent/guardian. The student will not be allowed to return to school until the infestation has been adequately treated and is no longer contagious. In cases of head lice or nits, students will not be allowed to return to school until <u>all</u> nits are removed. Periodic inspections are conducted throughout the school for the safety and health of the students and staff.

Any student or employee with a communicable disease for whom immunization is required by law or is available, shall be temporarily excluded from school while ill and during recognized periods of communicability. Students and employees with a communicable disease for which immunization is not available shall be excluded from school while ill. If the nature of the disease and circumstances warrant, our school may require an independent physician's examination of the student or employee to verify the diagnosis of communicable disease. This school reserves the right to make all final decisions necessary to enforce its communicable disease policy and to take all necessary action to control the spread of communicable diseases within the school.

#### **ILLNESS AND MEDICATION**

#### Please do not send sick children or children with a fever to school. Parents of children who

<u>vomit or have a temperature of 100 degrees or higher will be phoned and asked to pick their</u> <u>children up immediately.</u> Children who are determined by school personnel to be genuinely ill will be sent home. Children with COVID symptoms should be quarantined and the school office notified.

<u>All medication</u> is to be left with office personnel. <u>No</u> medication to include prescription, nonprescription, over-the-counter, diet pills, cough drops, vitamins, Tylenol or its generic equivalent are to be kept by a child. This is to promote safety.

<u>Prescription</u> medications will only be administered if an accompanying physician-signed prescription comes with it. This includes any prescription or over-the-counter cold and allergy medications.

Tylenol or its generic equivalent, other pain medications, and cough drops may be provided <u>without</u> a physician's prescription.

Parents must also give <u>written</u> permission authorizing school personnel to administer medication to your child. This includes all prescribed medications, Tylenol or its generic equivalent, over-the-counter sinus and /or cold remedies, cough drops, vitamins, and/or herbal supplements. Please complete the MEDICATION AUTHORIZATION form for your student. These are kept in the school office.

All medication sent to school should be in the original container, clearly marked with the <u>student's</u> <u>name</u>, <u>name of medication</u>, <u>dosage</u>, and <u>time it is to be taken</u>.

NOTE: The school does <u>not</u> provide <u>any</u> medications.

#### HOMEWORK

The homework philosophy at Grace Christian School is that it should be used as practice to master skills or topics previously taught in the classroom. Assignments may be given any day except Tuesday for elementary students and Wednesday for secondary students. (Exceptions are given twice yearly for mid-term and final exam weeks.) Homework is assigned only after the skill or topic has been taught in the classroom and students given an opportunity for guided practice and follow up. Late assignments receive a letter grade reduction for each school day that it is late. Students are required to write all assignments in their planners. Parents should access MySchoolWorx for any updates in assignments.

#### Make up Work:

Students are permitted <u>two-days</u> for each day of excused absence (not to exceed 10 school days) to make up missed homework, assignments, quizzes and tests (the clock starts the day the student returns to class). Make-up work is assigned by the teacher and due at the normal class time. Extensions are only permitted by administrative approval.

#### HONORS AND AWARDS

#### VALEDICTORIAN / SALUTATORIAN AWARD

The students who receive this award must be a senior and have the highest/second highest grade average for the four years of senior high, grades nine through twelve. In order to be considered for valedictorian or salutatorian a student must have been awarded grades earned for senior high course work attempted at Grace Christian Schools for a minimum of two (2) semesters by the end of the first semester of their senior year, and must be a member of the graduating class at the time of graduation. (In other words, seniors must earn credits at GCS for at least one semester during their 11<sup>th</sup> grade year before moving on to their 12<sup>th</sup> grade year.) Students must have at least a 3.0 cumulative grade point average. In the event of tied ranks for valedictorian and/or salutatorian, the principal shall award co-valedictorian and/or co-salutatorian positions.

The senior having achieved the cumulative grade point average as stated below will receive the following honor:

#### **CLASSROOM CERTIFICATES**

**Christian Character** - Students who were selected for the Character Honor Roll receive this certificate. One student from each class is selected who best displayed a consistent Christian Testimony for the reporting period (nine weeks).

**Principal's Honor Roll** - Students who were selected for the Principal's Honor Roll for any of the four quarters will be noted on our Honor Roll. Students with an "A" average with no grade less than a "A" for all classes for the year will receive a certificate.

"A & B" Honor Roll - Students who were selected for the Honor Roll for any of the four quarters will be noted on our Honor Roll. Students who received a "B" average with no grade less than a "B" for the entire year will receive a certificate.

#### MISCELLANEOUS

#### HURRICANE DAYS

It is the policy of Grace Christian School that when Pasco County cancels school for severe inclement weather, Grace Christian School will also be closed. You can check Bay News 9 on the TV or check the Pasco County website at <a href="http://www.pasco.kl2.fl.us">www.pasco.kl2.fl.us</a>.

#### LOCKERS (Approved 8/13/15)

Lockers and combination locks are provided by Grace Christian Schools of Pasco for students in grades 6 through 12. Only school locks are allowed on lockers. Any student who loses or damages a lock or locker must pay for it. Lockers are to be kept neat and clean. Food or beverage items (other than the current day's lunch) may <u>not</u> be <u>stored</u> in the lockers. No open containers are permitted. All liquids must be in a container with a screw on top or sealed. Stickers, decals or writing in or on lockers is prohibited. At the discretion of the administration a student's locker

may be checked at any time. If a student or parent refuses the search, the student may be subject to expulsion. Students are not permitted to open another student's locker or touch another person's lock or locker. Locks are to be locked at all times accept when accessing items from the locker. Failure to follow the Locker/Lock procedure will result in disciplinary action. Non-Grace Christian School issued locks will be cut off and discarded.

#### LUNCH PROGRAM

Grace Christian Schools of Pasco is happy to provide a lunch program to ensure your student receives a healthy lunch each day. It is not required to order off the menu. Students may bring their own lunches. Students ordering, however, must use the order form provided and must turn in the total amount owed when the order is turned in. We will not keep a "charge account" for lunches. If a student accidentally does not have a lunch, one will be provided from the Daily Menu selection. A LUNCH MONEY DUE slip will be sent home that day and payment is expected to be turned in on the next school day. Students that bring their own lunches must be provided with their own utensils (if required). It is also requested that home lunches be "student friendly" allowing students to open or microwave without assistance. **NOTE: Students who bring their own water bottles must be sure they have a screw-type cap so as to prevent spillage**.

#### PHONE CALLS

Parents may contact a child through the school office. Permission for a student to make a call must be obtained from the office. <u>Permission will be given only for bona fide emergencies</u>. **Students may <u>not</u> call for forgotten books, homework, P.E. clothes, sports uniforms, work, etc.** Arrangements for after-school transportation are to be made prior to the students' arrival at school each day. Phone calls may not be made by students wishing to make plans with a friend, go home with a friend, have a friend over, etc.

#### SPORTS SPECTATORS

Grace Christian School is a member in good standing with the Suncoast Christian Conference of Athletes. As part of our desire to present ourselves as a testimony of Christ, we ask that all spectators be modest in dress, appearance and deportment at all athletic events.

#### **TRANSPORTATION**

The school office <u>must</u> have on file the name of any person who has permission to transport your child. Students will <u>not</u> be released without proper authorization. If last minute changes are necessary, please call the school office. Students in grades 9-12 who may be driving a vehicle to and from school must register with the school office. <u>Students who fail to drive responsibly on campus will forfeit the privilege to drive to school</u>. Only students who have submitted a written parental permission slip to the school office, <u>in advance</u>, may ride with a student driver.

#### **VISITORS**

We welcome visitors at Grace Christian School. Visitors to classrooms must make prior arrangements with the principal. Parents who wish to observe their child's class must make prior arrangements through the principal. <u>All visitors must sign-in at the school office and receive a</u> Visitor Pass. They must also sign-out when leaving the building.

#### **VOLUNTEERS**

Volunteers are an important part of the ministry of the school. We encourage you to be involved in your student's education. <u>All volunteers MUST have a background check completed before volunteering in any capacity at the school</u>.

Procedure:

- Please pick up a Background Check Application at the school office.
- Contact the school secretary to schedule a 10-minute appointment with Mr. Pratt
- Be sure to bring your driver's license and the \$10.00 fee.
- Background checks must be complete annually.

**Dress Code:** When visiting or volunteering on school grounds or during school functions elsewhere, it is important to maintain our Christian testimony in appearance. Therefore, we request that all forms of dress be appropriate for the occasion, modest. When volunteering for Grace Christian School either on or off school grounds. Volunteers may wear loose- fitting slacks, long jeans or mid-knee length skirts. Shorts are not permitted.
